ELIGIBILITY/ADMISSION CRITERIA

MPhil Degree Programs:

- **Qualification:** ○ **Basic Academic Qualification:**
 - PharmD and BPharm with min cGPA of 2.45 out of 4.00 ○ Masters/ Bachelors' (BS) 04-year degree in relevant discipline with min cGPA of 2.45 out of 4.00 or 60% marks in annual system or equivalent qualification from any HEC recognized Higher Education Institution
 - Valid GAT General/Equivalent tests, with a passing score of a minimum of 50%
OR
 - Entrance Test conducted by Dow University of Health Sciences (min. passing score 50%)
- **Admission Committee Interview:**
 - Short listed applicants only



PhD Degree Program Pharmacology ○ **Qualification:** ○ PharmD/ BPharm with MS/MPharm/MPhil or equivalent degree from a HEC-recognized Higher Education Institution

○ **CGPA:**

- Minimum CGPA of 3.0 (out of 4.0) or 60% (in the annual system) in the MS/MPharm/MPhil/equivalent degree from HEC-recognized higher education institution

○ **GAT/HAT General Test:**

- Valid GAT General/Equivalent tests, with a passing score of a minimum of 60%

OR

- Entrance Test conducted by Dow University of Health Sciences (min. passing score 50%)

○ **Subject-specific Test:**

- Conducted by Dow University of Health Sciences. A passing score of a minimum of 60%

○ **Admission Committee Interview:**

- Short listed applicants only
- Submission of a short research proposal in the area of applicants' interest ○ ○

Conditional Admission:

- cGPA Requirement:
- Holders of MS/MPharm/MPhil or an equivalent degree from a HEC-recognized Higher Education Institution with a CGPA between 2.5 - 2.9 can also apply for conditional admission provide: ○ They meet all other requirements for admission in a PhD program (Subject-specific test; Interview, etc.). ○ Successfully complete additional course(s).



- Students Currently Enrolled in MPhil/Master's Programs:
 - Applicant who is currently enrolled in a MPhil/Master's or equivalent program in a HEC-recognized Higher Education Institution may also apply for conditional admission provided:
 - They submit an official confirmation that they have submitted their thesis which has been accepted awaiting defense. ○ MPhil/Master's degree must be awarded before the start of the PhD program.
- They must satisfy all the other requirements of admission in a PhD program (i.e., cGPA, subject-specific test; interview, etc.).
