





A meeting of the Complaint Redressal Committee (CRC) was held under the chairmanship of Prof. M. Saeed Quraishy, Vice Chancellor, Dow University of Health Sciences (DUHS), Karachi on 16<sup>th</sup> October 2024 at 11:30 a.m. at VC Board room, 4<sup>th</sup> Floor. Administrative Block Dow Medical College Campus of DUHS for "CONSTRUCTION OF SEMINAR HALLS AT OJHA CAMPUS, DUHS, KARACHI." Tender notice. Ref no: DUHS/W&S/NIT/151 NIT No. DUHS/W&S/2024/1240, Dated: 10th Sep, 2024

- 2. As per Rule 31 of SPPRA 2010 (Amended up to date), the Complaint Redressal Committee formally examined the grievance/complaint of the bidder, M/s. Maqbool Ahmed & Co. hereinafter referred MACO as vide letter # MACO/HO/KHI/1289-24 dated 09<sup>th</sup> Oct 2024 received on 11<sup>th</sup> Oct 2024 at 09:45 am attached at (Annexure- A).
  - 3. The Committee composition is as under:

- 5. The meeting started with a recitation from the Holy QURAN. The chair welcomed the participants and then commenced the proceedings.
- 6. The Chairman briefed the participants of the Committee about the agenda of the meeting while Mr. Pir Muzaffar Ali Shah, Director Planning & Development & Mr. Abdul Rahim Khan, Director Works & Services were also called upon to respond to procedural & technical queries.

The Director Planning & Development apprised the participants that all relevant procedures including the advertisement, and opening of technical & financial bids have been executed in total compliance with SPPRA Rules. The Notice of Inviting Tender (NIT) was hoisted to the DUHS and SPPRA websites EPADS-S-

USMAN KHALIL Account Officer Office of the Accountant General of Sindh 240930437 and published in 03 widely circulated leading dailies of English, Urdu, and Sindhi languages viz. Dawn, Daily Jang, and Daily Awami Awaz on 11<sup>th</sup> September 2024. The Technical Bids were opened on 26<sup>th</sup> September 2024 at 11:30 am. After the entire bid evaluation of the tender documents, the results were informed to the bidders on dated 09-Oct-2024 through email. (copy attached)

- 8. The eligibility /mandatory criteria were evaluated by the procurement committee based on the documents submitted by the bidders. The Evaluation Report was communicated to the bidder via email on 09th October 2024. As per the Bid Evaluation Report, M/s. Maqbool Ahmed & Co. was declared Technically disqualified. As the bidder failed to compliance the mandatory requirement of the bidding documents.
- 9. Foregoing in view, Dow University of Health Sciences (DUHS) received the grievances from the applicant M/s. Maqbool Ahmed & Co against the Bid Evaluation Report (copy attached) of the subject tender. The grievances of the applicant are attached in Annexure "A"
- The CRC committee decided to reevaluate the Eligibility /Mandatory Requirements and discussed each clause of the Mandatory Requirements to which the applicant has an objection.
- 11. In accordance with Rule 31(3) Sindh Public Procurement Rules 2010 (amended up to date). Complaint Redressal Committee after examination of grievances, scrutiny of records, hearing the representative of the aggrieved applicant/firm, due deliberation and discussion, decided upon the grievances of the bidder. The detail of the grievances, deliberations & decisions of the Complaint Redressal Committee is given below.

### The mandatory requirements at Sr No: 1 Tender purchase receipt

### **Deliberation & Decision of the Complaint Redressal Committee**

The appellant contended that he submitted the hard copy of the tender fee in the form of payorder and didn't upload it in the technical profile as it was not required. Due to this, he didn't score in the technical criteria to qualify in the competitive bidding process.

The chairman of the CRC further added that SPPRA has recently adopted a new mechanism for uploading bids. Therefore, all relevant and supporting documents must be submitted through the E-PADS system, and hard copies will no longer be accepted.

In the case of the pay order and tender fee, these must also be uploaded with the technical bid to ensure they are available during the bid evaluation & future audits. Furthermore, attaching the pay order or receipt for the tender fee in the technical profile is a mandatory requirement.

It is worth mentioning here that the Technical Report mentioning the technical score was only conducted once the bidder qualified in the Eligibility /Mandatory Requirement as per clause of the bidding document 26.1 & 26.2

Furthermore, The appellant expressed his concerns regarding transparency issues in the newly adopted E-PADS system. In response, the Chairman of the CRC stated that DUHS has no authority in this matter. He emphasized that the current practices align with the recently adopted SPPRA regulations and that DUHS is fully compliant with the E-PADS system.

In addition to the above, the bidder demanded to view his sealed bid security, which he had submitted during the tender opening. Addressing his concerns, the sealed envelope was shown to him, and he was satisfied that it remained intact as it was originally submitted.

Furthermore, the CRC concluded that the evaluation of bids was done as per bidding documents by following SPPRA rules, and as per the condition of the mandatory requirement, the pay order & tender fee need to be uploaded in the technical bid so that it would become part of the technical profile beside that, a hard copy of any sort of documents was not accepted if the bid is submitted on Epad system. The same was also communicated in the NIT.

The mandatory requirements at Sr No: 2 Valid PEC Registration Certificate up to June 2025 and onwards with Pakistan Engineering Councils in relevant category and specialized codes as mentioned against each work.

### **Deliberation & Decision of the Complaint Redressal Committee**

The appellant contended that the objection of the procuring agency was not valid, as the attached PEC certificate expired in June 2024 in the technical profile; however, the procuring agency demanded a valid certificate by June 2025, according to PEC Notification No. PEC/Const/Ext/07/2024, all PEC certificates received an extension until September 2024.

Furthermore, the CRC clarified that the supporting documents regarding the extension of the PEC Certificate need to be submitted with the technical profile for a better understanding of the procurement committee members. However, the committee agreed to consider the PEC Certificate valid till Sep 24.

The mandatory requirements at Sr No: 5 At least (02) ongoing projects of a similar nature and with a value of at least 80% of the estimated cost of the work.

### **Deliberation & Decision of the Complaint Redressal Committee**

The appellant briefed the forum that he submitted two different projects of Remaining Works, and it should be considered a valid project as he also brought the BOQ in the meeting to clarify it.

The CRC informed the bidder that supporting documents should be attached to the technical bid for better understanding by the procurement committee members. However, the committee agreed to consider the project valid.

The mandatory requirements at Sr No: 6 Biodata of Engineering and Technical staff working with the firm as required and mentioned in bidding documents.

### **Deliberation & Decision of the Complaint Redressal Committee**

The appellant briefed the forum that he submitted the bio data of the Engineering & technical staff however, degrees were not required in the mandatory requirement.

The CRC agreed to consider the bio data of the Engineering & technical staff without attaching the degrees.

The mandatory requirements at Sr No: 11 Annual Income Tax Returns of the last three years must be provided.

### **Deliberation & Decision of the Complaint Redressal Committee**

The appellant stated that the government had granted an extension to submit the returns. The firm is not ready to submit the returns, so the last fiscal year's returns were not submitted.

The CRC didn't agree with the statement and clarified that all participating bidders had submitted their last fiscal year's returns. Further, it was added that It is necessary to file your returns before applying for such a mega project, as this is a mandatory requirement of the project and it should be compliance.

The mandatory requirements at Sr No: 17. Bidder must have 15% tender bidding amount should be show in the bank's closing Balance at least three working day's before submission date.

#### **Deliberation & Decision of the Complaint Redressal Committee**

The appellant accepted that the above condition is not fulfilled by them.

Furthermore, it was also discussed during the meeting that, according to clause IB.18.2, all Appendices to the Bid must be properly completed and signed. The appellant asserted that all required documents were completed and stamped. However, the committee clarified that the General Conditions of Contract, Special Conditions of the Contract, Estimated Progress Payments, specifications, and drawings were not signed and stamped by the appellant. It was emphasized by the members of the committee that all signed and stamped documents are essential components of the contract agreement of this tender.

After that, the appellant demanded to view the bidding documents of competitors who submitted their bids properly completed and signed. In response to his demand, the documents were shown to him, and he expressed his satisfaction with the review.

Maqbool Ahmed & Co reviewed the technical findings and evaluation of bids and concluded that the Procurement mechanism as prescribed by the SPPRA Rules has been obeyed accordingly the evaluations have been done without any bias or subjectivity, and it's based on Merit.
- 2. The Complaint Redressal Committee unanimously decides that there is no apparent violation of Rule(s) as alleged by the Complainant. Hence, the Complaint Redressal Committee unanimously decided to reject the Complaint of Aggrieved Bidder, and the Modified/Final Bid Evaluation Report, in line with the Complaint Redressal Committee's decisions, will be integrated into the competitive bidding process.
